






Illustration: tension wrt tradition

1. The seriousness of the test



2. Originating in the practice

 Much of what is done in the name of proven experience is good. One shouldn't underestimate the need for new technologies. The opposite would be that health care implemented each new method in all hospitals simultaneously and in the same way, which would lead to stagnation (Läkartidningen 2010)

3. The practice as a mechanism for testing

Proven experience – that which experience has proved works in different groups and situations

... proven experience among more than 1000 general practitioners unambiguously shows that pre-defined forms concerning quantified alcohol consumtion patterns do not have any place in the clinical reality of everyday general medicine. (Läkartidningen 2010)

4. The practice as evidence

There is a lack of consensus and guidelines concerning pharmacological treatment after successful resuscitation. The suggested interventions do not build on the results of studies but on proven experience. (Läkartidningen 2010)

5. Amount/extent of experience (relating to a person)

The many doctors, primarily at big hospitals, acquire scientific knowledge, but do they get enough proven experience? Do they find the time for regular patient care and follow-up or are the patients too quickly referred back to primary care (*Läkartidningen* 2010)

6. Amount/extent of experience (relating to a collective)

Proven experience consists in methods that are relied on in health care and are regarded efficient. That which the community of physicians deems an established pratice can be included here. (*Läkartidningen* 2007)
